Sharing data with Patient Portal

Allow patients to upload data remotely.

When creating a new patient

During patient creation, under **Additional Options**, you can choose the features your patient can use for **data sharing**. For patients that are not using Accu-Chek branded devices, it is recommended to always leave the **Patient Portal Access** box ticked — as these patients will require Patient Portal Access to upload results to you from their home computer via the USB cable of the manufacturer of their device.

* It is recommended that for patients using Accu-Chek devices, you only click mySugr Data Sharing. For more information on mySugr Data Sharing, see the end of this document.

Using the **Patient Portal**, patients can remotely upload their data from their device, such as blood glucose meters and insulin pumps. In order to gain access to the **Patient Portal**, patients must have a valid email address attached to their profile.

ADDITIONAL OPTIONS Patient Portal Access Give your patients access to Patient Portal to remotely upload device data. Access permission requires a valid email address from the patient. Allow your patient to upload data from all supported device brands.

After you have created a new patient account, an email will be sent to the patient to complete the account creation and data sharing process.

The patient will be required to complete the following steps:

- 1. Set password for RDCP Patient Portal Account.
- 2. Verify password for RDCP Patient Portal.
- 3. Install Device Link to upload data via USB technology.

Have your patient keep a look out for this email, and suggest they check their spam folder if they do not see it in their inbox.

Uploading Accu-Chek[®] blood glucose meter data

This workflow is for Accu-Chek Aviva Connect, Accu-Chek Guide and Accu-Chek Guide Me blood glucose meters.

The Device Link icon and Accu-Chek 360° Connection Manager icon must both be visible in your system tray.

Using a standard micro USB cable, connect the blood glucose meter to your computer.²

If Auto-Upload-Accu-Chek is enabled, follow the on-screen instructions to complete the data upload process.

You may be required to sign in to your account to complete the upload process.

*To enable Auto-Upload for Accu-Chek devices, right click on the Device Link icon in your system tray of your PC, and select Enable Auto-Upload-Accu-Chek.

Uploading data from non-Accu-Chek devices

The Device Link icon and Accu-Chek Connection Manager icon must both be visible in your system tray.

Connect the USB cable from your computer to your blood glucose meter.

*It is possible that your non-Accu-Chek blood glucose meter may require the use of a special cable from the device manufacturer of the meter. Contact the meter manufacturer support team of the meter to acquire the necessary cable.

Right-click on the Device Link icon in your system tray.

Click on Manual Upload—Other Devices.

*Currently, Auto-Upload is not available for non-Accu-Chek devices.

Follow on-screen instructions to complete the data upload process.

You may be required to sign in to your account to complete the upload process.

mySugr Data Sharing

For patients using Accu-Chek devices, they can send you data without you having to upload data via a USB Cable by using the mySugr smart phone app. For more information on how to set up a patient to use the mySugr app, talk with your sales representative, or call 1-800-628-3346.
