Population Health Management

By using the Diabetes Data Dashboard you can identify and understand the needs of specific cohorts of patients and stratify the risk based on the 9 key care processes, current disease progression and optimisation of treatment therapies.

Data In One Convenient Place

The Diabetes Data Dashboard enables you to analyse data at a practice level and pro-actively review how well your patients are managing their diabetes. It provides you with a simple and efficient¹ way to evaluate and co-ordinate care for your diabetes patient population. Aggregated data can also be provided at a Primary Care Network (PCN) level.

The Dashboard provides you with a tool that can simplify data by taking large patient lists and breaking it down into a manageable size. You are able to interrogate the data and search on specific criteria, the output is presented in an easy to read and graphical way.

Risk Stratification

The Dashboard provides you with the mechanism to identify which patients are in need of a review, escalation or intervention.

If you wish to check which of your patients have not had their 9 NICE* recommended annual care processes, the clear presentation of the data

makes it easy to interpret and navigate and progress where appropriate.

The Diabetes Data Dashboard enables your practice to not only take the guesswork out of risk stratification but also helps you to make the most out of every patient consultation with the relevant data to hand. It provides you a simple way to discover more about your patients.

The disease progression feature enables you to select patients that require intervention or escalation and manage accordingly.

Medication Review

A medicines optimisation module enables a review of the patients prescribed medication and can assist you in managing your patient's to achieve appropriate polypharmacy.

QOF/QAIF Review

The system allows you to understand the variation in your QOF/QAIF data. It also helps to target your interventions more accurately and also have the potential to improve your QOF/QAIF payments.

Optimising Workforce Capacity

The Diabetes Data Dashboard can have a positive impact on your workforce by reducing workload through easy, simple data analysis. Any individual within your practice can use the dashboard, empowering the whole practice team to support diabetes care.



Utilising Whole Practice Team

The Dashboard can be used by any team member within your practice. By enabling admin/clerical staff to run reports this frees up the time of healthcare professionals so that they can deal with clinical matters.

For example, a report can be run on those patients who have not received any of their 9 care processes and they can then be pro actively invited to a clinic appointment.

Patient lists can be created based on the risk stratification analysis which can then be reviewed by a Healthcare Professional.



Supporting Multidisciplinary Teams (MDT) Reviews

The Dashboard will support MDT reviews by specialist diabetes teams across your PCN by providing you easy access to specific patient data. Interventions and escalations can easily be facilitated by the practice or specialist team.
